**Request:**

1) the number and type of crime outcomes recorded for a) rape and b) sexual assault. The outcome should follow the Home Office outcome categories (please see a list at the end of this email\*). Please only include crimes that had an outcome recorded, and group them by the year the crime outcome was recorded, rather than the year the crime was first reported

2) for part 1 of this request, please provide a breakdown of the sex and ethnicity of the victims (including a breakdown of crime outcome by ethnicity)
