Request:

 - ii) Sexual assault (including offences 17A, 17B, 20A and 20B)
 - iii) Causing sexual activity without consent (offence 22A)
2. Please state how many persons aged between 10 and 16 inclusive (at the time of arrest) were arrested on suspicion of the following sex offences in the years 2013, 2014 and 2015. (Please supply separate figures for each age - ie 10, 11, 12, 13, 14, 15, 16):
 - i) Rape (including offences 19C, 19D, 19E, 19F, 19G and 19H)
 - ii) Sexual assault (including offences 17A, 17B, 20A and 20B)
 - iii) Causing sexual activity without consent (offence 22A)
